2. Citrus Cup Management will select vendor locations and will assign Commercial Vendor locations in its sole discretion and may make such changes as needed or deemed necessary.
3. Citrus Cup/Florida Morgan Horse Association and WEC will not be responsible for any loss, personal injury, nor for damage to the Commercial Vendor or for any property of any kind or nature that may be lost, destroyed, or damaged.
4. Each Commercial Vendor shall be responsible for injury to any person or damage to any property while on WEC property, whether caused by any product owned, provided by, or sold by Commercial Vendor or any action or activity of said Commercial Vendor, its agents, or its employees.
5. Commercial Vendor shall indemnify and hold harmless Citrus Cup/Florida Morgan Horse Association and WEC against all claims or damages, of any kind or nature, that may arise from any injury or damage that may occur or be occasioned by any action of said Commercial Vendor, its agents, or its employees, or any product sold or provided by said Commercial Vendor.

7. The move-in date for ALL VENDORS is no earlier than Tuesday April 22, 2025
9. The tear down and vacate for ALL VENDORS is no later than Saturday, April 26,2025 after the end of show Saturday night.
